



The Dividend Fund's rating was 3 stars among 1131, 3 stars among 1075 and 5 stars among 821 Large Value funds for the 3-, 5- and 10-year periods ended 31 December 2023. The top 10% of products in each product category receive 5 stars, the next 22.5% receive 4 stars, the next 35% receive 3 stars, the next 22.5% receive 2 stars, and the bottom 10% receive 1 star. The Overall Morningstar Rating for a managed product is derived from a weighted average of the performance figures associated with its three-, five-, and 10-year (if applicable) Morningstar Rating metrics. The weights are: 100% three year rating for 36-59 months of total returns, 60% five-year rating/40% three-year rating for 60-119 months of total returns, and 50% 10-year period, the most recent three-year period actually has the greatest impact because it is included in all three rating periods. **©Morningstar Rating** is for the AFAZX share class only; other classes may have different performance characteristics.

#### Key Definitions:

Index - Morningstar Large-Mid Cap Value - The index provides a comprehensive depiction of the performance and fundamental characteristics of the Large-Mid Cap Value segment of U.S. equity markets. Index - Russell 1000 Value - Market-capitalization weighted index of those firms in the Russell 1000 with lower price-to-book ratios and lower forecasted growth values. Index - S&P 500 - A market capitalization-weighted index of 500 widely held stocks often used as a proxy for the stock market. TR - indicates "Total Return". Active share - The fraction of a fund's portfolio holdings that deviate from the benchmark index. The active share of a mutual fund ranges from zero (pure index fund) to 100% (no overlap with the benchmark). Upside Capture Ratio - measures a manager's performance in up markets relative to the market (benchmark) itself. It is calculated by taking the security's upside capture return and dividing it by the benchmark's upside capture return. Downside Capture Ratio - Downside Capture Ratio - Downside Capture Ratio provide as those periods (months or quarters) in which market return is less than 0. In essence, it tells you what percentage of the down-market was captured by the manager. Forward Dividend Yield - An estimation of a year's dividend expressed as a percentage of the current portfolio value. 30 Day Subsidized/Unsubsidized SEC Yield - Represents net investment income earned by a fund over a 30-day period, expressed as an annual percentage rate based on the fund's share price at the end of the 30-day period.
